### Terms and Conditions:

1. All non-profit animal organizations may participate free of charge.
2. You may solicit donations or sell items that will benefit your non-profit group.
3. All animals MUST be on a leash or confined to a crate or pen at all times.
4. You may bring adoptable animals, but they MUST be up to date on all vaccinations, healthy, well-behaved and free from parasites
5. You must provide your own tent, tables, chairs, supplies, etc.
6. Pick up and dispose of trash and animal waste around your area.
7. No food sales allowed unless you are a food vendor.
8. No alcoholic beverages of any kind are allowed.
9. Power supply is VERY limited – you may bring generators.
10. You may start setting up at 8am and must be completely set up by 12 pm.
11. All participants are asked to remain until 5pm- Take all your supplies/belongings and make sure your area is clean when you leave.
12. If rain date (May 13, 2012) is used all regulations will still apply.
